From the Desk of the Rabbi Rabbi Rachel Smookler

Growing up in Southwest Minneapolis

"Growing up in Southwest Minneapolis was idyllic. I am not just sifting through

was idyllic. I am not just sifting through my now foggy brain, nor am I only selectively recalling the fond memories. It was truly a slice of paradise.

The neighborhood kids would play together every evening until our mothers opened up the front door and called out loudly, "kids, time for dinner". We never concerned ourselves with safety. I don't think there were even helmets back then! We hopped on our bikes and rode up the Minehaha Creek to the local Seven Eleven all by ourselves.

From kindergarten through 6th grade I couldn't have, in a million years, conceived that my life was about to change. John Burroughs Elementary School was all I had ever known. It was made up solely of the kids in our neighborhood. And looking back, who were those kids? We were all mostly white upwardly mobile kids. Our dads were our t-ball coaches. Our parents were on the PTA. We had annual block parties And a community recreation center...I felt safe. I felt embraced by the love of my parents. I had piano lessons, Hebrew school, Saturday school, dance lessons and summer camps. Little did I know my life was about to change.

The first day of 7th grade at our junior high was a shock...really a shock.Yes, the kids from my elementary school class were there, but so were hundreds of other new 7th graders. And they were definitely not from around my neighborhood.

They were from what I would now call the inner city, although at that age I had never heard of any inner city. I had heard some talk about students being bused in from other neighborhoods in an effort to integrate students who came from a less advantaged background with communities whose schools were highly ranked. I and the other kids I attended grade school with walked to school. My eyes were wide with new surroundings, and I was thrown into a world where I didn't know everyone anymore.

I could tell that there were rumblings of something going on with my parents and some of their closest friends.

The junior high was not providing the level of education that they had hoped for. My brother was already at a prestigious private school, and my parents were doing everything they could to have me tested so that I too could attend this private school.

Little did I know that if it were not for space, my parents would have sent me there off the bat and I would never have even been exposed to Ramsey Junior High. Perhaps they did want to give the public school a chance, but that one 7th grade year has stuck with me. And as an adult, those memories pull at me and make me think that I am responsible for helping to remedy the inequalities in our communities.

In reading a book review for *Our Kids*, written by Robert Putnam, and the author of *Bowling Alone*, I was reminded of the one year I spent at Ramsey Junior

High. Putnam, a social scientist who graduated from Harvard, brings to light the widening income gaps, the changes in family life and family structure, and neighborhoods and schools that make it even harder for those below to work their way up.

For the last year, we have seen intensely the widening inequality gap, racially and educationally. As you all know by now, whether the Torah portion teaches us "Thou shalt not stand Idly by", or whether we discuss the dozens and dozens of times our torah commands us to not oppress the widow, the orphan and the stranger, to hold out our hands to the those in need....this is a religious obligation of ours.

In light of educating myself about the ever-widening racial and educational gaps in our society, I found that more and more I identified with Putnam, the author of *Our Kids*, and his premise which states: "Every summer camp you went to or every piano lesson you got or every time you went to soccer club, you were getting some advantage, that somebody else out there — Mary Sue — was not." It's not an accusation, but a rallying cry, a call to come to the altar and help save someone else's children.

Putnam goes on to say that, "If we can begin to think of these poor kids as OUR kids, we would not sleep for a second before we figured out how to help them".

Peter Edelman, a lawyer, a policy maker and a law professor at Georgetown University Law Center's on Poverty, Inequality and Public Policy worked for the Clinton Administration, for Robert Kennedy, and has written the book, *So Rich, So Poor, Why it's so hard to end poverty in America...*" . He recently came to Rochester as Keynote speaker for the Rochester Business Journal's Power Breakfast series.

I have known Peter my entire life. He is one of my father's oldest and dearest friends from growing up in Minneapolis. The combined activism of Peter and his wife, Marion Wright Edelman, the president and founder of the Children's Defense Fund, have had a profound impact on me and my family. At the recent Rochester Conference on Poverty, Peter said, "We need public policy at all levels, private and civic action as well as public policy, and personal responsibility in all ways".

So much of what we can and must do is civic and local. Here in Rochester, everywhere local around the country, civic and local. ...the civic responsibility.

Think about getting young people into jobs of the 21st century, a local responsibility. If there is not local responsibility, nothing happens. Peter concluded his Keynote address with the words: "I always close with a short quote from Rabbi Abraham Joshua Heschel, Dr. Martin Luther King's dear friend, a deeply spiritual man, and an author of many books of great length. But here, a tweet, before there was Twitter, if you will". He said, "We are not all guilty, but we are all responsible."

Peter's rallying cry is that without the programs to fight poverty that are already in place, we would have twice as many people in poverty in our country...more than 90 million people instead of the 45 million people we do have. "So, please", he urges... "don't sit silently when you hear nothing works. That is just wrong, wrong, wrong". A modern Midrash in the title of Robert Putnam's new book, *Our Kids*, has made me see my obligation as a Jew in a new light. "If we can begin to think of these poor kids as OUR kids," he says, "we would not sleep for a second before we figured out how to help them." It comes down to one word, our....our kids instead of these kids.

Can I sponsor a cholent if someone else is sponsoring the kiddish?

Yes. It is not necessary to sponsor every component of a kiddish. We encourage sharing with our Temple family.

If food is left over from an Extended Kiddish I sponsored can I take it home?

Yes. You may have the extra food items such as salad or bagels. However, we ask that you come another day since we don't encourage carrying items out of Temple on Shabbat. Call the office to make arrangements.

Can I pay Temple to purchase and prepare food for a Bar/Bat Mitzyah?

Unfortunately no. Temple does not have sufficient volunteers nor paid help to support a large event. Some shopping help may be available. However, we add a 10% surcharge to help defray the cost of condiments, consumables, and kitchen maintenance.

How many people will I need to help with my Bar/Bat Mitzvah Kiddish?

Generally three of four people are needed, depending upon

your menu. If there are too few people and a large number of people being served (100+ including Temple Members), it makes for a very long day. However, if there are too many people there will not be enough room to work. It's helpful to line up help early to be sure you aren't left in a pinch at the last minute.

Who serves and cleans up from my child's Bar/Bat Mitzvah Kiddish?

Serving and clean up are generally done by help paid for by the family. If you don't have people to do this we may be able to help find someone at nominal cost. Please call the office

More Questions? Pricing? Please call the office. We'll be happy to provide the information. All of us at Temple appreciate the generosity, concern and care of our fellow congregants. Over time resources (both volunteers and tangible/intangible items) change. We all want to be open and flexible despite limitations. If you have a suggestion we'd love to discuss it. If you would like to help, even once in a while, please let us know; call the office for general and volunteer contact information.

Clarifying The Mystery Of Kiddish Sponsorship

We often read or hear that a person or group is "sponsoring" a kiddish, a soup, salad, or cholent. We also hear about sponsoring an "Extended Kiddish" or a Bar/Bat Mitzvah Kiddish. Perhaps because the word "sponsoring" is used with the word "kiddish" there is confusion regarding the differences among them. This article hopefully will be a step in demystifying the terms and providing additional important information.

We currently have four classifications for our Shabbat "Kiddish": The **Standard Kiddish**, the **Sponsored Kiddish**, **Extended Kiddish** and the **Bar/Bat Mitzvah Kiddish**. Note that sponsorship for a kiddish **does** not include the cholent or seasonal soup/salad. Currently we plan for approximately 35 people, except for the Bar/Bat Mitzvah Kiddish.

- **1.The Standard Kiddish** is paid for by Temple through the Kiddish Fund, including the "extras" such as the Cholent.
- **2.The Sponsored Kiddish:** (Minimum \$72) may be requested in recognition of a person or event. It defrays the cost to the Temple of the Standard Kiddish following Shabbat Services. Note: You may donate more than the minimum.
 - **A.** No extra or special foods are added.
 - B. Cholent, soup/salad (Minimum \$18 ea.) are not included in the Sponsored Kiddish; these items may be served but paid by Temple kiddish funds unless sponsored. Note: The person or group that is sponsoring the kiddish itself may also sponsor the above components, or another individual or group may sponsor one or more components of a kiddish without sponsoring the entire kiddish.

To request a Sponsored Kiddish or components (Soup/Salad/Cholent) the first step is to call the office two weeks in advance. Our Office Manager, Susan Sawler, will check if the requested date is available. Calling well in advance also gives Susan time to put the notice in the weekly Newsletter. Timely notice will also ensure your sponsorship will be announced at services.

3. The Extended Kiddish (Minimum \$200): An Extended Kiddish is also offered as a way to highlight an event, occasion or person. The Extended kiddish offers the ability to add extra food items. We maintain a list of items and prices from which you can chose. However, we try to remain flexible so if you'd like something that's not on the list, please ask.

The base price for an Extended Kiddish is also based on about 35 people. People requesting an Extended Kiddish can elect to have their entire donation pay for the food and disposables. Alternatively, they can request that extra food be kept to a minimum and that a slightly larger amount of their

Extended Kiddish donation go to Temple. A Temple volunteer will do the shopping if requested. A Temple volunteer will also do the plating or you may assist. Note: For menu items for which Temple preparation rather than purchase is requested (such as some salads), help in preparation and plating, usually Friday morning, may be required. Call the Office for details.

The first step in requesting an **Extended Kiddish** is to call the office **at least a month in advance**. The Temple Office Manager, Susan Sawler, will check the calendar to see if the date is available and provide the contact information for the Temple Volunteer to help plan the menu. Lead-time is needed to order some food items and to notify congregants and guests via the weekly newsletter and Shabbat announcements who may want to join the occasion.

3. The Bar/Bat Mitzvah Kiddish (\$36 kitchen charge)

This kiddish speaks for itself. The Bar/Bat Mitzvah Kiddish is quite different from the Sponsored or Extended Kiddish. Generally there are many more people attending, more food choices and extra touches to mark the occasion. For this kiddish the shopping and preparation are completed by family and friends, or the family may choose to use a Kosher caterer if a large luncheon will be served. Please call the office for details to ensure a smooth, stress-reducing experience.

It is also vitally important to call the Office right after making arrangements with Rabbi. Calling two or three months in advance should be sufficient to reserve the date and obtain additional information. After calling the Temple and firming up the date you will be given the contact information of a Temple volunteer who will help with menu items, ideas and suggestions, and provide answers to your questions, if desired.

Note: Unfortunately Temple has only a very limited ability to shop for large events. There is a 10% surcharge above the cost of food items, which are purchased by a Temple volunteer. These funds go to Temple, not the volunteer. The \$36 "Kitchen charge" helps offset the additional cost of the kitchen that occurs with large events, such as the cost of the Walk in cooler, gas ovens, microwave, and "incidentals".

FAQs:

Can I prepare foods at home and bring them to Temple?

No. The Temple maintains a kosher kitchen so items that require preparation must be produced in our kitchen. Items brought to Temple must be in their original unopened packages and with an appropriate Hechsher. Fruits and vegetables of course are the exception.

In addition, the Rochester Area Synagogue Presidents Council is planning a community-wide Scholar-in-Residence event in Spring 2016.
